## **Custody Record Review** Question sets for ICVs August 2024



This document takes you through some of the questions that ICVs can answer when viewing a custody record, either as part of their role as an ICV, or as part of a scrutiny panel. ICVs may also wish to watch the 'Custody Record Reviewing' bitesize training module, which they can access <u>here</u>.

This list of questions is detailed but not exhaustive and there may be other things that ICVs would like to note or comment on but provides a useful basis of the kind of questions to use when reviewing a record.

ICVA advises that when custody record reviews are undertaken, those areas in bold on the list above are completed for all detainees, with the other subsets of questions being used when appropriate for the specific detainee. Not all parts of the document will be applicable to all to detainees.
